# Coates Cyclery Mountain Bike Team Release Contract

I ACKNOWLEDGE THAT BY SIGNING THIS DOCUMENT, I AM RELEASING COATES CYCLERY MOUNTAIN BIKE TEAM (THE "TEAM") AND ITS RESPECTIVE OFFICERS, DIRECTORS, INSTRUCTORS, AGENTS, EMPLOYEES, MEMBERS, SPONSORS, PROMOTERS AND AFFILIATES (COLLECTIVELY "RELEASEES") FROM LIABILITY. THIS RELEASE IS A CONTRACT WITH LEGAL CONSEQUENCES. I HAVE BEEN ADVISED TO READ IT CAREFULLY BEFORE SIGNING.

## In consideration of membership in the Team, I hereby freely agree to and make the following contractual representations and agreements:

I acknowledge that cycling is an inherently dangerous sport and fully realize the dangers of participating in bicycle training rides, bike riding, instruction and races and FULLY ASSUME THE RISKS ASSOCIATED WITH SUCH PARTICIPATION INCLUDING, by way of example, and not limited to the following: the dangers of collision with pedestrians, vehicles, other riders or racers, and fixed or moving objects; the dangers arising from surface hazards, equipment failure, inadequate safety equipment, THE RELEASEES' OWN NEGLIGENCE, and weather conditions; danger of medical emergencies such as heart attack, stroke or heat stroke; and the possibility of serious physical and/or mental trauma, injury or death associated with athletic cycling training and competition.

For myself, my heirs, executors, administrators, legal representatives, assignees, and successors in interest (collectively "Successors") I HEREBY WAIVE, RELEASE, DISCHARGE, HOLD HARMLESS, AND PROMISE TO INDEMNIFY AND NOT TO SUE the Releasees and the sponsors of the Team or any Team related cycling event or the event's organizer or any promoting organizations, property owners, law enforcement agencies, all public entities, special districts and properties, and their respective agents, officials, officers, directors and employees through or by which the events will be held, (the foregoing are also collectively deemed to be Releasees) FROM ANY AND ALL RIGHTS AND CLAIMS INCLUDING CLAIMS ARISING FROM THE RELEASEES' OWN NEGLIGENCE, which I have or which may hereafter accrue to me and from any and all damages which may be sustained by me directly or indirectly in connection with, or arising out of my participation in or association with Coates Cyclery Mountain Bike Team and any Coates Cyclery Mountain Bike Team related event.

I understand and agree that situations may arise during the training rides, instruction and races which may be beyond the immediate control of the team or race officials or organizers, and I must continually ride so as to neither endanger myself nor others. I accept responsibility for the condition and adequacy of my equipment. I will wear a helmet on all training and instruction rides and races which satisfies the requirements of the USCF Racing Rules or Regulations and that can protect against serious head injury, and assume all responsibility and liability for the selection of such helmet.

I have no physical or medical conditions which to my knowledge would endanger me or others if I participate in these events, or would interfere with my ability to participate in these events. I agree for myself and my successors, that the above representations are contractually binding and are not mere recitals, and that should I or my successors assert my claim in contravention of this agreement, the asserting party shall be liable for the expenses (including legal fees) incurred by the other party or parties in defending, unless the other party or parties are finally adjudged liable on such claim for willful and wanton negligence. This agreement may not be modified orally, and a waiver of any provision shall not be construed as a modification of any other provision or as consent to any other provision or as consent to any subsequent waiver or modification. Every term and provision of this agreement is intended to be severable. If any one or more of them is found to be unenforceable or invalid, that shall not affect the other terms and provisions, which shall remain binding and enforceable.
